NARRATIVE

Suspect Hate / Bias Motivated:

1. AO: On 06/21/09 at 0517 hours while on uniformed patrol in a marked unit assigned to District 3 patrol, I was dispatched to 2951 SW 35th Pl Apt 144 (Woods Edge Apts) reference a domestic battery.

2. INV: Upon arrival I made contact with VI Courtney Smith who was crying and visibly emotional. C. Smith stated that her husband OF Zachary Smith W/M 02/18/84 picked her up by grabbing her T-shirt and threw her against the bedroom wall located upstairs in their apartment. C. Smith advised that she is in her third month of pregnancy with Z. Smiths child. C. Smith advised that Z. Smith arrived at his residence with an unknown female co-worker that he was partying with. C. Smith stated that she refused to have the unknown female who Z. Smith kept referring to as "baby", spend the night at their residence. C. Smith stated that a verbal argument took place over the female and questions of infidelity arouse. C. Smith stated that Z. Smith was intoxicated and she took the female to her house located somewhere in Haile Plantation. C. Smith stated that when she returned to her residence, a heated argument insued in the upstairs bedroom. C. Smith stated that she tried to get Z. Smith out of her bed which he refused and then forcefully grabbed her.

I contacted Z. Smith who was sitting on the couch in the living room. I advised Z. Smith of his Miranda Rights which he stated that he understood by answering yes. Z. Smith stated that he was downtown hanging out with a female co-worker. Z. Smith advised that he works for UF Florida Gators as an assistant coach for the football team. Z. Smith stated that he brought the female home because she was upset from breaking up with her boyfriend. Z. Smith stated that C. Smith was upset that the unknown female was at her house and accused Z. Smith of being unfaithful. Z. Smith stated that C. Smith yelled at him and denied picking her up and throwing her into a wall. Z. Smith had a visible red mark on his right bicep that he claimed was a result of breaking up a fight downtown at a club.

I observed that C. Smith's shirt had been stretched just above her right breast. C. Smith's account of the incident was consistatent with the redness to Z. Smiths' right bicep because she advised that she attempted to hit him while he was picking her up.

EMS responded to the scene as a precaution and C. Smith reported that she was not injured.

3. EV: Ofc Devereaux #720 photographed the scene and all of the involved parties.

- 4. From the statements made on scene, I determined that Z. Smith was the primary aggressor. I handcuffed (double-locked for fit), searched and arrested Z. Smith for aggravated battery on a pregnant female. I transported Z. Smith to ASO DOJ without incident.

- 6. ADD: C. Smith advised that she did not want to press charges against her husband. C. Smith and Z. Smith are husband/ wife and have been married for a year and live at the same residence. C. Smith was issued a GPD case report number, a Victims/ Witness brochure, and a domestic violence pamphlet.
